Job Summary:

Under the general supervision of the Construction Supervisor, performs skilled oxy-acetylene and electric arc welding, operates various excavation equipment and performs hard physical labor in the construction and maintenance of District structures, water mains and appurtenances. As a condition of employment, this position is required to standby and work as an emergency crew (duty) person on a rotating basis covering nights, holidays and weekends. Applies all standard safety practices.

Essential Functions:

Performs hard physical labor and works as a member of a crew in the construction, maintenance and repair of water mains, service laterals, fire hydrants and other appurtenances within the District's potable water system.

Cuts and welds light and heavy gauge metals and all sizes of pipe.

Operates and maintains all types of heavy and light equipment including, but not limited to, backhoes, excavators, dump and boom trucks, wheel loaders, skid steers, asphalt grinders, jackhammers and soil compactors.

Operates light equipment, including hand and power tools.

Transports equipment between District yard and various work sites as needed.

Performs braze welding or welding on copper or other materials.

Excavates service trenches, hot taps water lines and runs service leads and sets meters. Completes installation by backfilling and compacting excavations.

Functions as a competent person related to trenching excavation at the construction site, being knowledgeable regarding safety related policies and regulations, identifying and predicting hazards, placing and maintaining protective equipment and systems, and reporting on safety related incidents.

Reads and interprets grade stakes, improvement plans and assists in the layout of jobs at construction sites.

Assists with the updating of plans, drawings and mapping when alterations are made to the potable water system as the result of system maintenance and/or construction projects.

Essential Functions (Continued):

Assists with water distribution related tasks such as emergency and scheduled shutdowns, including notifying customers and other affected parties and/or agencies and ensuring District compliance with its National Pollutant Discharge Elimination System permit.

Standby and work as an emergency crew (duty) person on a rotating basis covering nights, holidays and weekends. Emergency crew personnel are required to be able to report to the District's headquarters facility within forty-five (45) minutes. Employees on standby may not consume alcoholic beverages or be under the influence of controlled substances, as described in the District's Policies Manual.

Performs related work as assigned.

Qualifications:

Education and experience equivalent to graduation from high school. Must have at least two years of equipment operation experience in water or sewer utility construction and/or maintenance. Experience operating a backhoe is preferred.

Must have one year of combined working experience with both gas and arc welding on various metals. Experience in construction and/or maintenance is preferable but not mandatory.

Must obtain a valid Class A California driver's license within one year of starting work at this position, and must be acceptable to the District's automobile liability insurance carrier. Must pass the Department of Motor Vehicles medical exam every two years and is subject to random drug and alcohol testing.

Must possess a Water Distribution Operator D2 certification (or higher) administered by the California Drinking Water Operator Certification program or obtain the required certification within one year of starting work at this position.

Must pass fit testing for an air purifying respirator.

The District:

The Vista Irrigation District was formed in 1923 to provide water to the community of Vista. The District also supplies water to portions of the cities of Escondido, Oceanside, San Marcos and some unincorporated areas of San Diego County. Located seven miles from the Pacific Ocean in northern San Diego County, Vista is the "climatic wonderland of the United States" with an average daily temperature of 74 degrees. Rolling hills and a pleasant rural surrounding, combined with relatively affordable housing prices and a strong community, make Vista an ideal place to live and work. Vista has been recognized in a national publication as being one of the "50 fabulous places to raise a family". In addition to the beautiful beaches to the west, within a 60-mile radius of Vista can be found the dynamic city of San Diego and the Mexican border to the south, snow-capped mountains and majestic deserts to the east, and Disneyland and the Los Angeles metropolitan area to the north.

The District supplies potable water to over 28,000 customers in a 21,160-acre service area with a population of over 133,000 people. The District receives local water from Lake Henshaw, which it owns, imported water from Northern California and the Colorado River via the San Diego County Water Authority (Water Authority) and the Metropolitan Water District of Southern California and desalinated seawater from the Claude "Bud" Lewis Carlsbad Desalination Plant via the Water Authority. The District currently employs 90 people.

Regular employees in this position may join the Teamster Union. The Welder-Equipment Operator is a non-exempt position and eligible for overtime compensation under the Fair Labor Standards Act and in accordance with District Policy.

The Vista Irrigation District is "an equal opportunity employer" and will consider reasonably accommodating qualified disabled persons. Reasonable accommodations can include, but are not limited to, changing job duties, changing the work shifts, accommodating schedules, relocating the work area, and providing mechanical or electrical aids.
